**ASSET SEARCH** . . . . . \$125  
Includes real property, vehicles, corporate, UCC and vessel/boat registration in Florida, and aircraft nationwide on an individual or company name.

**CIVIL SEARCH** . . . . . \$60  
Available for most counties in Florida. Search lists litigation on file with the Clerk of Court Recording Department in a particular county. Does not include pending or dismissed cases.

**CONSUMER CREDIT REPORT** . . . . . \$25  
Includes a detailed list of information regarding an individual's history. To perform a search on an individual, they must provide you with a signed agreement.

**CORPORATE SEARCH** . . . . . \$25  
A computer printout obtained from the Florida Secretary of State of corporations and partnerships which an individual is associated.

**DEATH CLAIM SEARCH** . . . . . \$25  
A nationwide search conducted to determine if a death claim has been filed under a particular name and/or social security number.

**DRIVING RECORD** . . . . . \$25  
Documentation obtained from the Florida Department of Highway Safety and Motor Vehicles listing a 3, 7, or 11 year driving history of an individual.  
(Additional Fees: \$1 per page)

**LOCATE SEARCH** . . . . . \$80  
Multiple searches combined in an attempt to develop a recent address for an individual nationwide. (Additional Fees: 7% Service tax)

**NEIGHBORHOOD SEARCH** . . . . . \$35  
A nationwide search conducted on an address to obtain the name of the person and telephone number listed at that address along with 5 neighbors and their addresses and numbers. (Additional Fees: \$3).

**PROFESSIONAL LICENSING SEARCH** . . . . . \$30  
A search conducted by name on an individual to determine if they hold a professional license in Florida. Search will include nurses, physicians, realtors, contractors, nail technicians, etc.

**REAL PROPERTY OWNERSHIP SEARCH** . . . . . \$30  
A statewide alphabetical listing of all property owned in Florida by an individual or company, according to the previous year's tax rolls. (Additional Fees: \$1 per page)

**SOCIAL SECURITY NUMBER TRACE** . . . . . \$25  
A nationwide search listing names and addresses used with that particular number plus aliases. Information is not from the Social Security Administration.  
(Additional Fees: \$3 Plus \$2 Per Page)

**SURNAME SEARCH** . . . . . \$50  
A nationwide search conducted by a last name in particular geographical area that lists individuals with the same last name and their addresses and phone number.

**TITLE HISTORY** . . . . . \$50  
Certified documentation from the Department of Highway Safety and Motor Vehicle of past and/or present ownership of a particular motor vehicle registered in Florida.  
(Additional Fees: \$3 plus \$2 per page)

**TRW BUSINESS REPORT** . . . . . \$100  
This report may include one or more of the following: Payment trends, available credit lines, UCC filings, and debt history. When requesting this report please note, there is a chance that there will be no information on file, or a very small amount of information. The fee will still be imposed for the attempt to locate the record.

**UCC LIEN COPIES** . . . . . \$30  
A printout from the Florida Secretary of State, Division of Uniform Commercial Code. (Additional Fees: \$2 per page)

**UCC LIEN SEARCH** . . . . . \$25  
A printout from the Florida Secretary of State, Division of Uniform Commercial Code which lists the names of individuals or companies who have secured a loan with collateral.

**VEHICLE SEARCH BY ADDRESS** . . . . . \$30  
A printout listing all vehicle registered in Florida to a particular address.  
(Additional Fees: \$1 per page)

**WORKERS COMPENSATION SEARCH** . . . . . \$30  
A search for all claims of injury filed in Florida from 1979 to the present. Search can be conducted by claimant's name, social security number or employer name.
